

We wish to inform you that Regulation (EU) 2016/679 ("GDPR") provides for the new regulation for the protection of persons and of other subjects regarding the processing of personal data.

According to the indicated legislation, this treatment will be based on the principles of lawfulness, correctness and transparency and protection of the confidentiality and rights, according to the principles contained in art. 5 of the GDPR.

Pursuant to art. 13 of the GDPR, we therefore provide you with the following information:

a) Identity and contact details of the Data Controller.

Data Controller is GORTANI S.R.L. having its headquarter in Via Valli di Carnia, 9 -33020 Amaro (UD) which you can contact by writing to the following e-mail address: privacy@gortani.com, or call +39 0433.94174.

b) Purpose of the processing.

Personal data collected will be processed and used for the following purposes:

- closed contracts for the services of the Data Controller;
- fulfill pre-contractual, contractual and tax obligations from existing relationships with you;
- fulfill the obligations established by law, regulation, community legislation or order of the Authority;
- exercise the rights of the owner, for example the right to defense in court;

Provision of data and their processing (including communication by GORTANI S.R.L. for these purposes, necessary to manage contractual relationship or fulfillment of regulatory obligations) is mandatory and does not require your explicit consent, otherwise there is impossibility for the writer to establish and manage the contractual relationship.

- send you newsletters, commercial communications and / or advertising material per e-mail, post and / or text message and / or telephone contacts on products / services offered by Data Controller and detection of satisfaction degree with the quality of services.

We inform you that since you are already our customers, we can send you commercial communications relating to services and products similar to those you have already used.

c) Data processing.

In relation to all the purposes indicated above, data will be processed in such a way as to guarantee security and confidentiality, and can be carried out through manual, IT and telematic tools in order to record, organize, store, process, modify, select, extract, compare, use, interconnect, block and communicate the data.

d) Categories of subjects whom the data may be transmitted.

For the pursuit of the prescribed purposes, your personal data will be processed by duly authorized personnel of GORTANI S.R.L., The updated list of authorized personnel is kept at the headquarter office of Data Controller; such subjects are specifically appointed as Data Processors or Persons in Charge.

For some activities needs to communicate your personal data to third parties belonging to the following categories: external consultants, accountants, lawyers, credit institutions, service and consulting companies and third parties, appointed the execution of activities directly connected and instrumental to the provision of the services of or with which the Company has stipulated commercial agreements functional to the dissemination and development of the services to be provided.

Subjects belonging to the above categories operate in total autonomy as separate Data Controllers, or operate as (external) Data Processors for this purpose appointed by GORTANI S.R.L.

e) Data transfer abroad.

Your personal data may be transferred abroad, within and / or outside the European Union, always in compliance with the rights and guarantees provided for by current legislation.

f) Data retention times and other information.

Data Controller will process personal data for the time necessary to fulfill the aforementioned purposes and in any case for no more than 10 years. from the termination of the relationship for the purposes of service.

g) Rights of the interested party

The interested party can obtain from the Company confirmation of the existence or not of personal data in the Company's databases. In your capacity as an interested party, you are the owner of the rights referred to in Articles. 15 and subsequent. of the GDPR and precisely: the right to obtain from The Data Controller confirms that your personal data is being processed or not; it may also request and obtain the correction or cancellation of the same or the limitation of the processing that concerns him; the interested party may oppose the processing; interested party also has the right to data portability; to withdraw consent (except in cases where the processing is necessary for fulfill a legal obligation which the Data Controller is subject or for the performance of a task of public interest or connected to the exercise of public authority vested in the Data Controller);

Finally, the interested party has the right to lodge a complaint with the supervisory authority (Privacy Guarantor).
